Main duties / Responsibilities	<p>Implements Health and Safety measures in ITER premises for ITER staff and contractors; Develops and updates necessary templates and fill-in documents such as: Health and Safety individual sheets, Document unique required by law, Prevention Plans, Occupational Health and safety questionnaire, etc.;</p> <p>Monitors training needs on all matters related to occupational Health and Safety (e.g. first aid, safety for newcomers, etc.) and propose an annual training plan for the ITER Organization; Carries out training or speeches related to occupational Health and Safety; Participates in development and maintenance of procedures for occupational Health and Safety;</p> <p>Participates in the Prevention Plan development, anticipating potential hazards; Answers to departments' queries on Health & Safety related topic upon demand in a timely manner;</p> <p>Identifies, keeps and updates database of applicable legal requirements; Takes part/leads incident and accidents investigations; Takes part in the on-call duty service established by the ITER Organization outside normal working hours, including nights, weekends and public holidays; Performs other duties in support of the project schedule as described in the Detailed Work Schedule and the Strategic Management Plan; Performs other duties linked to the above purpose upon management request, as necessary; Maintains a strong commitment to the implementation and perpetuation of the ITER Safety Program, values and ethics.</p>
