To provide legal advice on the law applicable to the IO; demonstrating a profound understanding of the definition of international organizations, the rules and principles governing its operation, its structure and functioning, its procurement and of the relationship with other actors of international or national law, such as States, IO Members and stakeholders.

- Prepares legal advice on diverse substantive and procedural questions of the ITER Organization (IO), which include those related to administration, procurement and other operational related matters, such as questions on liability, insurance, etc.;

Main duties / Responsibilities	<ul style="list-style-type: none">• Provides legal advice on contract law in particular in the field of commercial law, public procurement, French construction law applicable to the ITER site, International Federation of Consulting Engineers (FIDIC) based contracts and the related claims and dispute resolution mechanisms (claim; Dispute Adjudication Board; arbitration);• Participates in the preparation and follow-up of contracts in support to the procurement office ;• Implements mechanisms of settlement of disputes for international organizations enjoying privileges and immunities;• Performs extensive legal research & analysis and prepares legal interpretation, opinions, studies, reports, and correspondence in his/her scope of expertise;• Identifies relevant new legal texts applicable to the IO in his/her scope of activities in order to inform the technical departments;• Performs comparative analyses of the legislation and best practices of the different international organizations when required;• May be required to assist in other areas of work of Legal Affairs, according to needs and priorities, as defined by the Legal Advisor;• Performs other duties linked to the above purpose upon management request, as necessary;• Maintains a strong commitment to the implementation and perpetuation of the ITER Safety Program, values and ethics.

- Reports to the Legal Advisor in the Cabinet of the Director General.
- Acts as an interface between all the ITER departments and the ITER Domestic Agencies.
