 As requested, revises the cost estimates for baseline scope reflecting advancing design maturity;

 Contributes to the monthly preparation of the Cost Report (that provides estimate at completion for assembly and installation work);

 Implements and maintains defined project management procedures as they effect cost estimation for assembly & installation, including provision of advice and training when necessary:

Ensures Purchase Request (PR) issuance is traceable for scope and estimate is consistent with the approved Construction cost baseline;

• Ensures the alignment of the scope boundary for IO assembly and installation cost estimate;

• Establishes competency in the information system (Cleopatra) cost estimation tool;

 Proposes improvements for cost estimation efficiency and effectiveness between IO and Construction Management as Agent (CMA);

May be requested to support any project/construction team and perform other duties in contributing to the execution of the project schedule;
Maintains a strong commitment to the implementation

Measures of effectiveness

- Produces costs estimates for assembly and installation in defined time window as prioritized;
- Provides relevant and timely advice to control account managers on cost estimation;
 Validates in due time cost estimates for project change
- Validates in due time cost estimates for project change requests for Change Control Board decision;
- Reports to the Project Control Construction Section/Division Head, primarily receiving instruction and support day to day from the Cost Control and Reporting Manager and the Cost Estimating Responsible Officer:
- Manager and the Cost Estimating Responsible Officer;
 Interfaces with other Divisions in ITER Organization, and the DAs for all matters of his/her responsibility;
- the DAs for all matters of his/her responsibility;
 In response to requests from the Director-General and/or the Head of the Project Control Office, or proactively, informs the DG/Head of the Project Control Office about any important and urgent issues that cannot be handled by the concerned line management and may jeopardize the achievement of the Project's objectives.
- Implements and maintains efficiently cost estimation processes as it affects assembly and installation;

• Monthly produces accurate and high level quality costs savings reports for Assembly and Installation works.
